• Report Writing Guidance

Occupational hygiene is concerned with the Anticipation, Recognition, Evaluation and Control of health hazards in the workplace; at each of these stages, effective communication is essential, and the production of formal written reports is one of the key methods of communicating occupational hygiene information. This new guidance, *Clear and concise report writing: guidance for occupational hygienists*, will help occupational hygienists produce clear and effective reports to achieve the aims and objectives for which they have been produced.

Direct Reading Devices Guide

Direct-reading devices (DRDs) are primarily used to monitor the atmosphere for airborne pollutants, and are also used to a lesser, but increasing extent, for the measurement of surface contamination. There are over a hundred suppliers in the UK of DRDs and several hundred different instruments available for purchase. Most users require a device which is specific, sensitive, accurate, small, lightweight and trouble-free. However, this is not always practicable and compromises have to be made. This Guide, *TG15 Technical Guide on Direct Reading Devices for Airborne and Surface Chemical Contaminants,* has been developed to provide some general background information and to assist in the selection, application and use of DRDs for workplace monitoring.
