Paying the proper penalty

IOSH has welcomed tougher penalties for employers who fail to fulfil their duties in protecting employees from injury and illness. According to a new report, changes introduced under the Health and Safety (Offences) Act 2008 have led to more cases being tried in the lower courts, higher fines for convicted offenders and more custodial sentences for bosses who pay little regard to the welfare of their staff or the public. IOSH Head of Policy and Public Affairs, Richard Jones, said: "We welcome the government's review of the Act and the Minister's message that rogue employers who gamble with workers' health and safety will face stiff penalties"

Getting the low-down on working at height

The Health and Safety Executive has revamped its advice on working at height, in plain language. Ten million workers are estimated to work at height in Britain every year, and falls are one of the main causes of death and serious injury in the workplace. IOSH Research and Information Services Manager, Jane White, said: "Health and safety information must reach those who need it – whether engineers scaling wind turbines or builders' apprentices using ladders in domestic settings – in the right format to be translated into knowledge and practice"

Work-related accidents in Ireland – the facts

IOSH commented on new figures from Ireland's Health and Safety Authority which showed that there were 46 people killed in work-related accidents during 2013, compared with 48 in 2012. Michelle Peate-Morgan, IOSH Ireland Branch Chair, said: "Any fatality in the workplace is a tragedy. All are preventable and we are equally concerned about the rise in children dying in agriculture and the increase in deaths in the construction sector. IOSH members in Ireland are committed on a daily basis to preventing injuries, fatalities and illness in the workplace"

Shot in safety

Executive decision

The Triennial Review of the Health and Safety Executive by the Department of Work and Pensions concurred with the views expressed in IOSH's evidence submission. It concluded that the HSE should be retained and continue as a nondepartmental public body

Trainers put on the spot

IOSH has asked over 6,000 training providers to take part in a survey to help shape its plans for the development of health and safety training. IOSH Commercial Executive Director, Caroline Holden, said: "Our training providers' views will help us better understand them, their markets, expectations and the pressures facing their organisations"

Safety and security integral to growth

IOSH hosted a major seminar at Intersec 2014, the world's meeting platform for the security and safety industry. The seminar at the event, held annually in Dubai, covered occupational health issues including noise exposure. Opening the seminar, IOSH Chief Executive Jan Chmiel said: "Workplace health and safety is of prime importance in a region which is in a period of sustained infrastructural and commercial growth"

In Parliament

- In the second reading of the Deregulation Bill, a number of MPs quoted IOSH's concerns on clause 1, which exempts certain self-employed workers from health and safety law
- IOSH was invited to give oral evidence on clause 1 to the Public Bill Committee on the Deregulation Bill
- IOSH hosted a successful event in Parliament on behalf of the Inter-Institutional Group on Health and Safety, launching a policy paper on the business case for engineering in health and safety. Sir John Parker, President of the Royal Society for Engineering, gave a speech to MPs, business leaders and IOSH members

IOSH to push bike safety

IOSH has now secured two representatives on Transport for London's construction logistics cycle safety group. Between 2008 and 2011, 56 per cent of the cycling fatalities in London have involved large commercial vehicles, including a disproportionate number of construction vehicles

Reducing road risks in Eastern Europe

IOSH is encouraging members to support a scheme to cut road accidents in Eastern European countries, under its new accession countries initiative. The Eastern Alliance for Safe and Sustainable Transport and the European Bank for Reconstruction and Development are working in Ukraine, Moldova and Azerbaijan as part of the UN Decade of Action on Road Safety 2011–2020.
